**BASIC COSTS:** Piece price, proof charge, handling charge and freight charges (see ordering information).

**PRINTING METHOD:**

CUSTOM TEMPORARY TATTOOS ARE PRINTED IN 4-COLOR PROCESS. This will allow your artwork to include all the conventional colors on the PMS chart; these colors closely match PMS colors with our exclusive manufacturing method and regular process screens but are NOT AN EXACT MATCH due to the special safe, cosmetic-grade, non-toxic, FDA certified inks we use in our production.

**BACK LABEL COPY:**

A one (1) color (black) imprint on back of Tattoo is supplied at NO CHARGE, including the required directions and ingredients plus your copyright information and any other copy, logo or coupon that you require and that will fit in the printable area.

**LAB SAFETY TESTING:**

Independent safety lab testing documentation including total elements, lead content, phthalates content, cadmium, heavy metals, mercury, toy safety, microbial, mechanical hazards, flammability, cosmetic labeling, toxics in packaging and toxicological risk assessment. Available upon request.

**CUSTOM QUOTATIONS:**

Please call us for almost any size, quantity or Tattoos with "Special Effects" that are not on the above Price List. Almost any size Tattoo sheet can be produced. When asking for your quotation please indicate "graphic image" size or "finished cut sheet" size as at least 1/8" space is required between each Tattoo image and between Tattoo images and the edge of the sheet. Prices do not include any bleed. Indicate total quantity and how many Tattoo sheet versions are required. PRICES ARE PER TATTOO SHEET VERSION. NO COMBINED PRICING. MUST BE ORDERED IN INCREMENTS OF 1,000 PIECES PER VERSION (EXCEPT FOR 500 PIECES MINIMUM).

**5TH COLOR OF WHITE INK:**

NO CHARGE for white ink. White areas will print as clear unless the 5th color of white ink is requested and indicated in artwork.

**SPECIAL INKS:**

Non-toxic inks containing pigments that are certified by the FDA for use in cosmetics are used in our Tattoos per current CPSIA requirements. **THESE INKS MAY APPEAR MORE SUBTLE AND INCONSISTENT IN COLOR THAN CONVENTIONAL PRINTING INKS. EXACT COLOR MATCH IS NOT GUARANTEED.**

## ORDERING INFORMATION

**PRODUCTION TIME:** Tattoos shipped in approximately 6 to 9 business days from receipt of artwork, purchase order and **proof approval** for most unpackaged bulk product.

- In addition to production time, please allow **at least 24 hours** for us to process your order and provide a proof.
- **Once proof is approved**, production and shipment will be **6 to 9 business days** for most bulk, unpackaged orders.
- Special Packaging, "Special Effects" Tattoos and large volume orders require additional time.

**PLEASE CALL FOR DETAILS BEFORE ANY DELIVERY COMMITMENT IS MADE.** SUBJECT TO CHANGE WITHOUT NOTICE.

**HANDLING CHARGE:** All shipments require a \$7.95(z) handling charge per location, plus freight charges or \$12.95(z) per location on a 3<sup>rd</sup> Party account. International shipments require a \$12.95(z) handling charge per location, plus freight charges, duties & taxes or \$19.95(z) per location on a 3<sup>rd</sup> Party account, plus duties & taxes.

**OVERSTOCK:** No overruns. No underruns. Exact quantity shipped.

**PACKING:** Product stacked neatly in rows, facing same direction. Packed and shipped in bulk.

**PACKAGING QUOTATIONS:** Complete customized fulfillment and contract packaging are available by quotation to meet all of your special packaging requirements. Please call for a special quotation.

## ARTWORK SPECIFICATIONS

**IF THE FOLLOWING ARTWORK SPECIFICATIONS ARE MET, THERE WILL BE NO SET-UP CHARGE.**

**ARTWORK SUBMISSION:**

- Art files must be set up in CMYK (4-color process) on a clear transparent background (**not white**) with desired colors properly assigned. For best color matching results or critical colors, please be sure to indicate PMS colors. **Please do not send RGB files as colors will not be guaranteed to match.** **Artwork must be set-up exactly to size, composition and color, as well as formatted to fit your sheet size.**
- **ARTWORK CHANGES WILL INCUR ADDITIONAL COSTS.**
- When emailing artwork please be sure to identify yourself and your purchase order number.

**ACCEPTABLE GRAPHIC ARTWORK APPLICATIONS:**

- We prefer high-resolution files, to be color corrected flattened images set-up in CMYK. If PDF, JPG, TIFF or PSD, please be sure file is at least 300 dpi at 100% of actual size. If sending a Vector EPS or AI file, should have the fonts converted to outlines and all placed images embedded.

**BACK LABEL COPY:**

- If graphic artwork or a logo is needed and will fit on back label, we prefer high-resolution files, to be color corrected flattened images set-up in 100% Black or grayscale. If PDF, JPG, TIFF or PSD, please be sure file is at least 300 dpi at 100% of actual size. If sending a Vector EPS or AI file, should have the fonts converted to outlines and all placed images embedded.

**FONTS:**

- **Convert all fonts to outlines/curves prior to sending your graphic artwork file.**
- If specific font is required, include all font suitcases and postscript printer files used in your graphic artwork file.

**PROOFS:**

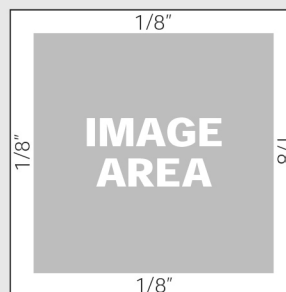
- Email proofs are required at \$11.00(z) per each version.
- **WE CANNOT PROCEED WITHOUT APPROVED PROOFS.**

**Please note that Tattoos are printed wrong-reading and will be right-reading when applied to skin.**

**ARTWORK GUIDELINES:**

- Tattoo art must allow a 1/8" space between each Tattoo image and between Tattoo images and the edge of the sheet.
- Our standard directions and list of ingredients are printed on the back of the Tattoo sheet. Please supply additional copyright information, address, logo, coupon, etc. (i.e., ©2024 ABC Company, City, State, Zip Code).
- Supply all artwork right-reading.
- **The special FDA certified non-toxic inks that we use to print Temporary Tattoos are close, but not as bright or consistent as conventional 4-color process (CMYK) inks.**
- White areas will print as clear unless the 5th color of white ink is requested and indicated in artwork.
- Temporary Tattoos are printed in 4-color process (CMYK).
- Temporary Tattoos can be backed in white for a more opaque look.
- Other forms of artwork are accepted at an additional cost.
- If artwork does not meet our specifications, **ADDITIONAL ARTWORK COSTS WILL BE INCURRED.**
